Two domestic flights in Peru ARE included. (See below)

The international flights to and from Lima, Peru are NOT included.

If you want to join us for this ONE-TIME-ONLY LOW-PRICED journey, please register immediately, as we need to reserve your place as soon as possible for the 2-day visit to Machu Picchu!

Only 1,500 tickets each are sold for the morning and afternoon entrances.

Once these are sold, there are no additional ones available.

Larger companies buy 100s at once, thus leaving fewer for smaller companies like Sacred Sites Journeys.

MAIN TOUR (November 2 - 10, 2025): \$2,979.00 Per Person, double occupancy, land only (includes two domestic flights in Peru; see below **) - via check, bank wire, or Zelle (US residents only can use Zelle). You may use your credit card to pay via PayPal. Please email Andrea at sacredsitesjourneys@gmail.com for the pricing. **For those who live outside the USA:** You also have the option to send the funds from your bank account or using a credit card via websites such as www.TransferWise.com or www.xe.com or others you may choose. Any fees that are applied for using these websites are your responsibility.

The price listed here is for a group of 8 people. If the final number is less than 8, there will be a surcharge, depending on the number of people in the group.

**** NOTE: Domestic flights in PERU:** A price of \$270.00 per person for the two domestic flights in Peru, LIM/CUS and CUS/LIM, has been used to calculate the pricing posted here for the Main Tour. An additional amount of \$120.00 per person for the return flight from Juliaca to Lima for those who take the optional excursion to Lake Titicaca has been used to calculate the pricing posted here. Should the price for the flight tickets increase, that additional amount will be passed on to the passenger. Once we reach our group minimum, we'll book the tickets for these flights. Please register as soon as possible in order to help the group reach the minimum, and keep the current price for the tickets, as well as for everyone to be able to book good-priced international flight tickets, and with good seat selection. (No one likes the middle seat, right?)

Single Room Supplement: \$295.00 - via check, bank wire or Zelle (US residents only can use Zelle). You may use your credit card to pay via PayPal. Please email Andrea at sacredsitesjourneys@gmail.com for the pricing.

NOTE: The Single Room Supplement applies ONLY for those who would like to secure a private room throughout the tour. ROOMMATES: We will be happy to try to find a suitable roommate for those who are traveling alone and would like to share a twin-bedded room with a person of the same sex. Per our Terms and Conditions provided with our Registration Form, registration for the tour will be held open until approximately 30

Terms and Conditions

Reservations and Payments: A non-refundable non-transferable deposit of \$900.00 per person is required for the main tour and an additional \$100.00 for the Lake Titicaca extension. If you register after July 1, 2025, payment in full is required with the application. Please submit the required amount, along with a completed and signed application to confirm your place on the trip.

Cancellations and Refunds:

SSJ recommends trip interruption/trip cancellation insurance. See **Insurance Protection Plan** section below.

Note: Should the trip fail to achieve minimum participation, SSJ reserves the right to cancel the tour, and will refund in full all payments received from those registered. Please note that in our over 25 years of operating tours to Peru, this has never happened.

Possible Tour Surcharge: The advertised cost for this Sacred Sites Journey is based on a group of 8 people, for the main tour and 8 people for the Lake Titicaca Extension. If the final number in either of the groups is less than 8, SSJ will issue a surcharge. This amount will be the difference in costs for the difference in the final number in the group and the group number that the tour is priced on. SSJ makes every effort not to have to enact a surcharge; but if we do, we keep it as small as possible. We will endeavor to keep the tour registration open until the entrance tickets to Machu Picchu sell out, OR until 2 weeks before the tour begins in order to fill the group. If assessed a surcharge, you will be notified of the amount as soon as the tour registration is closed. Payment is due upon notification, and must be received in our office immediately in order for your final tour documents to be sent to you.

Required Tour Documents: A valid passport must be held by each passenger. Your passport must be valid for six months after the date that you enter Peru. A Peruvian Tourist Visa will be issued free of charge to US and Canadian citizens upon arrival in Lima. For citizens from countries other than the United States or Canada, please contact the Peruvian Embassy in your country to inquire as to whether you will need to apply for your visa before departing for the tour.

Pre/Post Tour Options for a hotel and airport transfers in Lima: If you need to arrive in Lima before the tour begins and/or would like to stay on after the tour ends, once you register Sacred Sites Journeys can refer you to the local family-owned airport hotel that we've used with our groups in Peru since 1994. You will be able to book pre-tour and/or post-tour services with them on their website (in English). Services for pre-tour bookings include: meeting at the airport by an English-speaking representative from the hotel, private transfer to the hotel for overnight (includes breakfast), and transfer back to the airport the following morning for your flight to Cusco booked by SSJ. Post-tour bookings include: Meeting at the airport by an English-speaking representative from the hotel on your arrival in Lima from Cusco or Juliaca on the flight booked by SSJ, private transfer to the hotel for overnight (includes breakfast), and transfer back to the airport on the day of your international departure.

Accommodations: Based on twin-bedded rooms, or other accommodations requested by client such as a room

with a double bed for couples, with bath or shower as indicated. You are assigned accommodations as the guest of the facility selected. The tour operator reserves the right to substitute hotels of similar category.

Meals: Meals will be provided as per the final trip itinerary. Any foods or beverages not included in the program and purchased by you will be at additional cost. Tour price includes only foods and beverages that are provided to the entire group.

Sight-seeing: As specified in itinerary. Entrance fees are included.

Land transportation: As specified, by modern air-conditioned (where required) coaches.

Air: All airline tickets for the flights in Peru are subject to each carrier's Terms and Conditions as to passage and cancellation fees. Tours are sold in conjunction with the services of these approved carriers.

Not Included: Roundtrip international air to Lima, Peru. And items of a personal nature such as laundry, drinks, internet service/access and telephone calls, as well as any item that is not specifically detailed in the brochure or final trip itinerary.

Consumer Disclosure Notice: Sacred Sites Journeys (SSJ) and/or their agents act only in capacity as agents for the passenger in all matters connected with hotel accommodations, sight-seeing tours and transportation, whether by air, rail, bus, motorcar, boat or any other means and as agent holds itself free of responsibility for any damage occasioned by any cause. SSJ and or its agents will not be responsible for any damages, expenses or inconveniences caused by late departures or change of schedule, strikes or to their conditions, nor will be responsible for loss or damage to baggage or any of the passenger's belongings. All prices quoted are correct at time of being posted on the SSJ website and include the cost of operation of the tours, and are subject to currency and airfare changes. No attorney may be present during the mediation.
