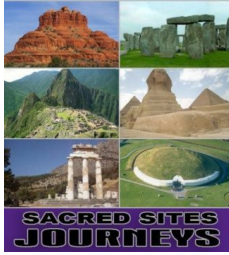

**This form is for you to keep; no need to return with your registration form.**

**Reservations and Payments:** A non-refundable and non-transferable deposit of \$1,000.00 per person for the main tour, plus an additional \$50.00 per person for each optional tour, along with a completed and signed application must be submitted with the reservation to confirm your place in the group. Final payment is due November 24, 2025. **Registrations submitted after final payment due date:** If you register after November 24, 2025, payment in full is due with your registration.

**Possible Tour Surcharge:** The advertised cost for this Sacred Sites Journey is based on a minimum of 16 people in the group. If the final number in the group is less than 16, in order to keep from having to cancel the journey, SSJ will issue a surcharge. This amount will merely be the difference in fixed costs for the different group sizes. If assessed a surcharge, you will be notified of the amount as soon as the registration is closed. Payment is due upon notification, and must be received in our office immediately in order for your final documents and airline tickets for the domestic flights in Egypt to be emailed to you in a timely manner. If your payment arrives at such a date that SSJ has to snail mail your documents to you with expedited service, you will be responsible to pay for these costs.

**Note:** Should this trip be cancelled by Sacred Sites Journeys, all payments received will be refunded, with the exception of any non-refundable deposits required by hotels and the cruise ship, airline tickets for flights in Egypt, fees charged by financial institutions for wire/money transfers, international airline tickets booked by the passenger, and any other personal expenses incurred.

NOTE: All drinks, including bottled water, are an additional cost, even at meals provided in your travel package.
