

TERMS & CONDITIONS

This form is for you to keep; no need to return with your registration form.

Reservations and Payments: Along with a completed and signed application to confirm your place in the group, a non-refundable and non-transferable deposit of \$500.00 per person is required, plus an additional \$50.00 per person if you are registering for the Hot Air Balloon Ride for those paying via check. For those using other payment options, all fees incurred are the responsibility of the client.

Final payment is due 60 days prior to the beginning of the journey, on **September 2, 2020**.

Registrations submitted after final payment due date: If you would like to register for the journey after the date the final payment is due (September 2, 2020) SSJ will be happy to take your registration. Bookings for the flights in Egypt, as well as all hotel and wooden sail boat accommodations will be on request and SSJ will notify you if space is available.

Cancellations and Refunds:

Possible Increase in Fees for Private Entrance into the Osierion and the Great Pyramid: Should the fees for these private entrances increase, the additional amount will be divided by the final number of people in the group and you will be notified of this amount. Payment is due upon receipt.

Possible Tour Surcharge: The advertised cost for this Sacred Sites Journey is based on an established minimum level of participation, i.e. the group size on which the pricing was calculated. If the final number traveling in the group falls below this number, in order to keep from having to cancel the journey, SSJ will issue an additional supplemental charge. This amount will merely be the difference in costs for the different group sizes, and no commissions for SSJ will be included in the amount. SSJ makes every effort not to have to enact this, but if we do, we keep it as small as possible. If assessed a supplemental charge, you will be notified of the amount as soon as the registration is closed. Payment is due upon notification, and must be received in our office immediately in order for your final documents and airline tickets for domestic flights to be emailed to you in a timely manner.

Note: Should the journey fail to achieve minimum participation, SSJ reserves the right to cancel it and will refund in full all payments received (with the exception of any non-refundable deposits made by SSJ to hotels or boat, as well as any airline tickets purchased for the flights in Egypt).

Required Tour Documents: A valid passport must be held by each passenger. 2) Women: Your current passport must be valid for 6 months after the date that the tour ends. 3) Men: Your current passport must be valid for 1 year after the date that the tour ends.

Air: For the flights in Egypt, all airline tickets are subject to each carrier's Terms and Conditions as to passage and cancellation fees. Tours are sold in conjunction with the services of these approved carriers.

Accommodations: Based on twin-bedded rooms with bath or shower as indicated. You may request other bed configurations though SSJ cannot guarantee that your request can be fulfilled. You are assigned accommodations as the guest of the facility selected. The tour operator reserves the right to substitute hotels or wooden sail boat of similar category.

Meals: Meals will be provided as per the final itinerary. Any foods or beverages not included in the program and purchased by you will be at additional cost. Price includes only foods and beverages that are provided to the entire group. NOTE: All drinks, including bottled water, are an additional cost, even at meals provided in your travel package.

Sight-seeing: As specified in itinerary. Entrance fees are included.

Land transportation: As specified, by modern air-conditioned coaches.

Air: All airline tickets are subject to each carrier's Terms and Conditions as to passage and cancellation fees. Tours are sold in conjunction with the services of these approved carriers.

Not Included: Items of a personal nature such as laundry, drinks, internet service, telephone calls, as well as any item that is not specifically detailed in the itinerary posted on the website.
