**Reservations and Payments:** A non-refundable deposit of \$1,000.00 per person for either Part 1 or Part 2, or for both, along with a completed and signed application must be submitted with the reservation to confirm the trip.

**FINAL PAYMENT is due February 25, 2026.**

**Possible Tour Surcharge:** The advertised cost for this Sacred Sites Journey is based on a group of 16 people for Part 1, Part 2 or for both. If the final number traveling in the group falls below 16, in order to keep from having to cancel the journey, SSJ will keep the registration open as long as possible to gather more people. We must have a minimum of 10 people registered by February 25, 2026 in order to be able to operate this group. Once the registration is closed, SSJ will issue a surcharge. This amount will merely be the difference in costs for the different group sizes. SSJ makes every effort not to have to enact a surcharge; but if we do, we keep it as small as possible. Payment is due upon notification, and must be received in our office upon immediately upon receipt.

**Cancellation of Trip by Sacred Sites Journeys:** Should this trip be cancelled by Sacred Sites Journeys, all payments received will be refunded, with the exception of any non-refundable deposits to our ground operator for hotels, fees charged by financial institutions for wire/money transfers, airline tickets booked by the passenger, and any other personal expenses incurred.

**Possible Currency Exchange Rate Surcharge:** Pricing is based on the exchange rate between Euros and US Dollars at the time of pricing of the tour. If this rate changes by the time final payment is due, there is a possibility of a surcharge to cover this difference.

**Required Tour Documents for US Citizens:** A valid passport must be held by each passenger.
